Dear Sir or Madam:

This is a final determination regarding your private foundation classification. This letter modifies our letter dated, November 3, 1977, in which we determined that you were an organization described in section 509(a)(2) of the Internal Revenue Code (Code). We have modified your foundation status to that of a public charity described in sections 509(a)(1) and 170(b)(1)(A)(vi) of the Code, effective for tax years beginning July 1, 1999.

Your tax exempt status under section 501(c)(3) of the Code is not affected. Grantors and contributors may rely on this determination unless the Internal Revenue Service publishes a notice to the contrary. Because this letter could help resolve any questions about your private foundation status, please keep it with your permanent records.

If you decide to contest this determination in court, you must file a petition for declaratory judgment in the United States Tax Court, the United States Court of Federal Claims, or the United States District Court of the District of Columbia must be filed before the 91<sup>st</sup> day after the date this determination was mailed to you. Please contact the clerk of the appropriate court for rules regarding filing petitions for declaratory judgments and refer to the enclosed Publication 892. The last day for filing a petition

for declaratory judgment in the United States Tax Court is March 2, 2004. You may write to the United States Tax Court at the following address:
